-Pick-up date is:

September 25, 2019

-Print information clearly

-Mark the quantity of each item you wish to recycle

-Total up your recycling fees & add the \$7.00 pick-up fee to calculate the total cost

-Items must be placed at the curb/end of your driveway by 6 am on pick-up date

-Appliances with doors MUST have the doors separated from the unit

-Items NOT pre-paid using this reservation form will NOT be picked up

-Pick-up may take more than one day depending on the quantity of material scheduled in your area

-These guidelines are outlined to ensure clear communication between the homeowner & McLeod County Environmental Services to make sure we take what you have authorized us to remove from your curb/driveway
